As of January 31, 2013, the Reporting Persons, in the aggregate, beneficially own 894,232 shares of the Common Stock of the Issuer, representing approximately 6.1% of such class of securities. The Reporting Persons have the right to purchase an additional 205,000 shares of Common Stock pursuant to the terms of common stock purchase warrants issued on October 22, 2010, which are not exercisable except upon sixty-one (61) days prior written notice to the Issuer. The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 526,713 shares of Common Stock representing approximately 3.6% of the class and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, andMr. Kolchinsky as the manager of Capital, each beneficially own 894,232 shares of Common Stock of the Issuer representing approximately 6.1% of the class. The percentage of Common Stock beneficially owned by each Reporting Person is based on a total of 14,656,916 shares of Common Stock of the Issuer outstanding as reported on Issuer's Form 10-Q filed with the SEC on November 08, 2012.
